- 1.29.1 The bid is liable to be disqualified in the following cases
  - i Bid not submitted in accordance with this document.
  - ii During validity of the bid, or its extended period, if any -
    - 1 Bidder reduces his quoted revenue to "Gujarat State Commission for Protection of Child Rights"
    - 2 Bidder modifies or withdraws its bid.
