The Administrator, Guruvayur Devaswom, Guruvayur invites competitive online bids for the execution of the following Works from financially sound and well experienced registered “**C**” class & above Contractors of Guruvayur Devaswom/ Kerala Public Work Department, who have successfully completed at least one similar work during the last 3 Years.

The firm period of the tender will be 2 Months from the last date fixed for receipt of tenders. All bid/ tender documents are to be submitted online only and no manual submission of the same shall be entertained. Late Tenders will not be accepted. Bidders shall remit the tender fee and EMD using the online payment options of e-Procurement system only. For Tender documents, Bidders are advised to visit the “Downloads” section of e-Procurement website (www.etenders.kerala.gov.in) and click Tender search by Organization > Guruvayur Devaswom. See detailed instructions on making online payment using Internet banking facility of SBT.

Single transaction for remitting Tender Fee and EMD: Bidder should ensure that Tender Fee and EMD are remitted as **ONE single transaction and not separate. Separate or split remittance for Tender Fee and EMD shall be treated as invalid transactions.**

Tender documents duly filled in, e- payment form duly filled; scanned true copies of Registration Certificate duly attested by the Administrator, Guruvayur Devaswom/ the Superintending Engineer, PWD Kerala, are to be submitted online.

The scanned copies of registration certificate duly attested by the Administrator, Guruvayur Devaswom/ Superintending Engineer, PWD, Kerala, Preliminary Agreement, Bid Capacity certificate shall be submitted online and subsequently in a separate cover physically before the time fixed for Tender opening. More details on EMD & Tender Fee/ Bid submission fee are mentioned in this document.

The bids shall be opened online at the office of the Administrator/ Executive Engineer on **11AM 17 August 2017** by the <Competent Tender Opening Authority> in the presence of the Bidders / their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any

other valid reasons, Tender opening process will be done on the next working day at the same time and place.

Online Tenders/ bids are to be accompanied with a preliminary agreement executed in Kerala stamp paper worth Rs.200/-. Tenders/ bids received without online preliminary agreement will not be considered and shall be summarily rejected.
