



## **DJ RAVISH'S PERFORMANCE TERMS FOR SHOWS**

### **TECHNICAL:**

1. Pioneer DJM 800 Mixer
2. Pioneer CDJ 2000s (2 no's)
3. 2 high power full range monitors to be placed on the left and right of setup connected to the booth out of the DJ mixer.
4. 2 Tables inside the console area to keep music.
5. 1 Cordless Mic

All inputs must be line-checked and Monitor systems must be fully functional and in a show ready state. It is expected that all sound equipment provided is of professional quality, in perfect working condition, and is accompanied by professional, competent technicians/engineers. No Sharing of Headphones or any other personal belongings.

### **PAYMENTS:**

1. 50% of the artist fee has to be paid as a confirmation advance and the balance 50% on the day of the show before it begins.

## OTHER:

1. The client has to provide for return air tickets  
(All bookings to be done in the name of **RAVI KUMAR SHARMA**).  
Airport pick up and drop shall be provided for in the mode of transport specified below.
2. Artist shall have ground transport provided for at all times in no less than an A/C Cab.
3. In Case of International Shows, the client has to bear for the visa charges.
4. Artist shall be provided with no less than 5 star hotel accommodation and have all food and beverage bills taken care of. Hotel shall be given billing instructions by sponsor/promoter before artist checks in. Artist shall have an individual room at hotel. **(No sharing with any other Artist/Performer)**
5. The performance duration will be **150-180** minutes. However, if the artist wishes to continue he may do so on his sole discretion.

## Sponsor/Promoter is required to provide for the following:

1. Artist shall be provided with ample refreshments back stage.
2. At the venue, entry shall be made prior to the show and will have a promoter representative present at all times to facilitate entry and movement to backstage area.
3. All event flow information as well as time slot information shall be provided and communicated to the artist by **ONLY** a representative from sponsor/promoter



4. Artist information and background shall be communicated in length to any other artist performing at the same event.
5. Artist will need to meet any other artist/performer well before the start of event.
6. Artist shall require all credentials/all access badges well before start of event.
7. Artist shall require a 20 minute sound check at least 5 hours prior to event.
8. Artist shall require 2 runners at any given time to help with bags and other equipment at the venue.
9. Only authorized persons from sponsor/promoter to be allowed on stage/console area while artist is performing. All onstage areas will otherwise be sterile at time of performance.
10. Artwork/Flyer for the event needs to be approved by the artist/manager.
11. Artist shall have the right to a provide guest list, which will be prepared for the venue prior to the show.
12. Artist's Guest Lists will remain open and honoured for entry from Open to Close, absolutely no time limitations or cut offs – please advise all door staff.



## DISCLAIMER:

1. The confirmation advance is non refundable. The same would not be returned if the show is cancelled due to reasons attributable to the client or if the client fails to comply with any of the above terms of the contract, or in case of natural disasters or happenings DJ RAVISH is unable to perform. Inability to perform due to such mishaps or any other cause beyond artist's control will relieve the artist of all contractual obligation.
2. Failure to meet any of the above requirements is not acceptable. In the event of a breach by the Promoter of any of the conditions herein, Artist may cancel the performance without liability and the promoter shall be obliged to pay the full contracted fee.
3. DJ Ravish specializes in Bollywood music. However, the preference and taste of music varies from person to person & therefore, DJ Ravish cannot be held responsible if some proportion of the crowd dislikes the music or complaints to the promoter/sponsor regarding the same.
