TECH RIDER

- Two Pioneer CDJ 2000's CD Players.
- One Pioneer DJM 800 mixer.
- Two (2) loud monitor speakers.
- Two microphones of good standard (if they are wireless then battery must be fully charged and a spare should be provided if needed).
- Monitor volume must be accessible to Talent during performance.
- Monitor volume must be derived from a source other than that of the house system.
- Technical engineer on standby during performance.

TERMS & CONDITIONS

- 50% advance payment to book the artist's calendar, and other 50% be made only in cash on the event day before the scheduled time of performance.
- Accommodation and Conveyance for artists, managers and technicians has to be borne by the client.
- A sound check is necessary prior to performance.
- Green room to be set up near the performance arena for the artists.
- Artist Security is sole responsibility of the hiring agency.
- TDS Deductions would be as per government rules and regulations.
- The airline chosen for travelling shall be subjected to artist's preference.
- Extra baggage costs on flight need to borne by client.
- If the scheduled performance is cancelled on the day of the event, client is liable to pay 100% amount.
- Any cancellation / reduction of the performance days would have to be compensated with 50% cancellation charges of the above said amount.
- Advance / Full Payment once done shall not be refunded in case of event cancellation.
- Artists are subject to availability.
- In case of any dispute the final decision would be made by Ahmedabad Jurisdiction.
